Institutional membership – US

US Institutional membership includes membership privileges for the Institutional Representative (i.e., the individual who coordinates the campus public safety program for the institution) and up to 18 Professional Members (i.e., an employee of a member institution holding an executive, managerial, or supervisory position) depending on the member package purchased. Note that Institutional membership should be purchased by the Institutional Representative or his/her designee.

Institutional Membership

Institutional membership is open to colleges, universities and K-12 schools (public, private, sworn or non-sworn) throughout the United States, Canada and other countries. The individual who coordinates the law enforcement program for the institution is designated the Institutional Representative. The Institutional Representative must be a full-time employee of the educational institution and not compensated by any contract security service or private company.

The Institutional Representative's membership is activated immediately upon purchase.

Institutional membership – International

Non-US Institutional membership applies to two-year, four-year or secondary schools; public, private, sworn or non-sworn outside the U.S. Dues are based on each country's per capita income as defined by the [World Bank Economy List](#). The individual who coordinates the campus public safety program for the institution shall be considered to represent that institutional system and be designated the Institutional Representative with full membership privileges. Note that Institutional membership should be purchased by the Institutional Representative or his/her designee.

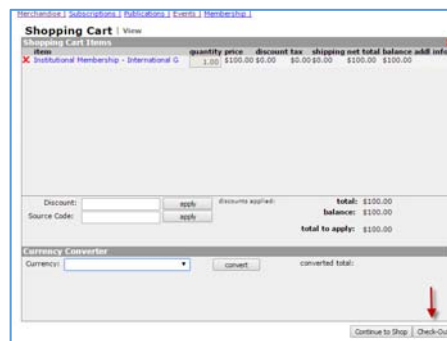
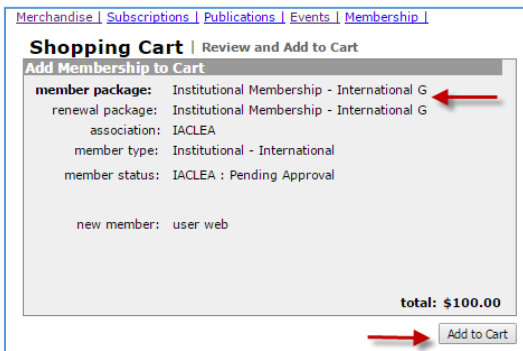
